**WHEREAS** NYSARC, Inc. has requested that all Chapters, including The Arc Westchester, review their By-Laws and approve amendments reflecting changes made in the New York State Not-for-Profit Corporation Law, the format of the NYSARC Model Chapter By-Laws, and changes to the NYSARC governing structure; and

**WHEREAS** the Governance Committee of the Board of Directors at its meetings on August 9, 2017 and August 24, 2017 reviewed and approved a series of changes to The Arc Westchester By-Laws; and

**WHEREAS** the Executive Committee at its meeting of September 6, 2017, approved all proposed changes made by the Governance Committee, Inc.; and

**WHEREAS** the Board of Directors of The Arc Westchester at its meeting on October 24, 2017 reviewed and approved the proposed changes to The Arc Westchester By-Laws; and
